City of Victoria Workers Ratify New Collective Agreement

We wrapped up the latest round of bargaining at the City of Victoria after five full days, and our members have ratified the changes to their collective agreement. Some

of the improvements were increases to holiday and vacation pay/ benefits, increases to a number of leave provisions and their boot allowance, a new provision on Dirty Pay, casual benefit increase, an annual \$650 for members using their FSR's, long-term service pay, and wage increases of \$0.25 + 3.24%, 4%, and 3%. Which is an increase of (about) \$4.50, which brings the City wage rate up to \$44.95 per Journey hour on January 1st, 2024 (without the other benefits), and full retroactive pay. We have a long-term working relationship with the City of Victoria stemming back to the turn of the last century, and it's great to see both of us still continue to see value in that relationship. I would like to thank Local 230 Shop Steward Peter S., and ABM Cory McGregor for all their hard work in this latest round of bargaining.

Business Manager's Report

After Meeting with the Mediator assigned to BC Construction bargaining in February, per the Protocol Agreement. After six days, she withdrew, citing, there were too many outstanding issues and the parties should renew trade level bargaining to attempt to get closer to resolving outstanding issues in the trade agreements. In reply the IBEW set aside March for bargaining with the Union Electrical Contractors, and we have reached a trade level deal. The Mediator booked back in to see if she could help foster an overarching deal covering off the remaining items for all trades, and although we came close we couldn't agree on some key points. At this point in time the Mediator is preparing her Report for the BC Labour Relations Board and it is incumbent on the Parties to reconvene separately and together to decide next steps throughout April. I know the last six to eight months have been financially difficult on members as inflation is hitting high points in fuel, groceries, utilities and mortgages, and we are pushing every button to ratchet what we can from our contractors while keeping them profitable, keeping our members employed. The Construction Agreement opens up on May 1st and the 14 construction unions, negotiating the 40-odd collective agreements in BC construction have never historically been this close to concluding bargaining in a timely way in four decades. Our Dockyard members working in Esquimalt, Rocky Point and Nanoose are up to begin bargaining next and we are waiting patiently for that to begin.

NANAIMO CORRECTIONAL CENTRE



The Island construction marketplace is smoking hot with many larger projects underway like the new Nanaimo Correctional Centre, Cowichan Secondary School, and Nanaimo Regional Hospital, Cypress Gardens in Comox, while many others are to begin ramping up in the next few months like Cowichan

Hospital is set to need 250 electricians and apprentices at peak, and will begin ramping up early this summer. Other projects we expect to see awarded very soon are first-phase of Harris-Green a 3.5 city block project, the Telus project both downtown Victoria, the Museum Securities Archive project in Colwood, more large apartment blocks throughout Langford, and the Plant Lab in North Saanich and the Belleville Terminal Redevelopment Project.

Nomination For IBEW Local 230 and Election Call

Nominations for Officers of Local Union 230 will be held consistent with the IBEW Constitution, the Local 230 Bylaws, and any variation as described herein as follows: Anyone desiring to be nominated must be present during the special called meetings to hold nominations, or provide a written and signed statement of willingness that they will accept the specific nomination. No member may be a candidate for more than one Office. Anyone nominated to more than one Office must declare the Office for which they will be a candidate.

In order to be nominated, a member must have a minimum of two (2) years of continuous good standing in Local Union 230. Good standing means that the member is current in their payment of dues and has been for the two (2) years preceding the nominations. Apprentices are not eligible to hold Office in the Local Union.

Nominations will proceed in the order of Offices as listed in the IBEW Constitution whose term of Office shall be the balance of three (3) years (to July 2026).

President Greg Gyorfí has appointed Chris Baker to perform the role of Judge of the Ballot and Shane Scott as the Sergeant of Arms for the purposes of all nomination meetings and election venues for the counts. Judge Baker has named two (2) tellers from the Local to assist with the collection and ballot count.

NOMINATION CALL FOR UNION OFFICERS
